TERMS AND CONDITIONS OF LOAN

I WILL BE SUBJECT TO THE FOLLOWING TERMS & CONDITIONS UPON APPROAL OF THE LOAN:

- 1. I shall repay interest at the rate determined by Mining & Petroleum Savings & Loan Society Limited (the "Society") until the loan is fully repaid.
- 2. The first repayment instalment will be paid after one fortnight from the date the loan is advanced out of my fortnightly salary/wages and remaining instalments be paid each fortnight thereafter until the loan is fully repaid.
- 3. The Society shall deduct from my General Savings the equivalent of the repayment amount to cover any defaulted instalment and any interest arrears that had accumulated therewith.
- 4. Upon leaving/resigning from my employer, the outstanding amount of loan will automatically become due and I shall repay the money to the Society immediately. I have signed an Authority for the money to be deducted from my salary/wages or other monies due to me from the company which shall be irrevocable by me.
- 5. I shall notify the Society of my intention to resign or take leave without pay and thereof without any demand by the Society the loan to repay on regular periodical instalments to be determined, arranged to be determined, arranged and agreed to between myself and the Society from time to time.
- 6. Additional loans may be provided by the Society if in the opinion of the Society, the additional loan will confer the most benefit to me and my family.
- 7. Withdrawals from Savings will be possible only if in the opinion of the Society that in doing so will confer the most benefit to me and my family.
- 8. I shall not reduce the above said instalment under any circumstances without the approval of the Society
- 9. I shall observe all the Rules of the Society and conditions as laid down by the Board of Directors.
